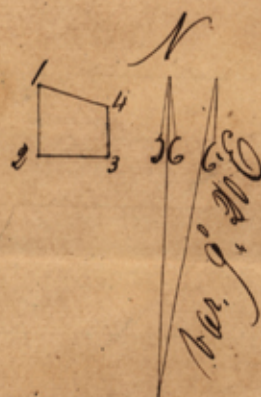

Being the quantity of Land to which he is entitled by virtue of Land Warrant No 2543 dated the 3rd day of March 1838 for 320 acres land

Commencing at the 3rd cor of Survey No 167 at a stake on the W Side of the Bayou Charles from which an Elm marked R bears N 45° E 6 1/2 m a Hickory marked F₁ bears N 26° W 4 1/2 m
