John Chisum, 200 acres on the upper side Straight Stone Creek, between his own, Francis Luck's and Charles Dean's line: also, 400 acres, beginning where Edward Hubbard's line corners on Woods on the south side of the North Fork of Straight Stone Creek, running eastwardly; also 400 acres, beginning on Goram Brown's lower line, on the south side Little Straight Stone Creek, thence off toward the branches of Flyblow Creek; also 400 acres, beginning at Shadrach Tribble's corner, white oak on the north side Little Straight Stone Creek, extending southerly and joining John Vaughn and Wm. Collins. Transferred to Wm. Collins, J. D. (From Surveyor's Notes entitled Entries from Major Drury Stick's Old Book, beginning 1738. The Notes cover territory that is now Halifax, Pittsylvania, Henry, and Patrick Counties. Formerly in possession of Mrs. E. N. Clement, of Chatham, Virginia.) (John & Margaret).

23 Apr. 1757. John Chisum, 400 acres, branches of Flyblow Creek, beginning at a Black Jack in Goram Brown's line, thence along Francis Anderson's line. (Pittsylvania Co., Va., Grants). (John and Margaret).

(Pittsylvania County was formed in 1767 from Halifax; in 1776, Henry was formed from Pittsylvania; in 1794, Patrick was formed from Henry).

1767. John Chisum sells negro girl Jean to Thomas Yuille and Thomas Murdock. (Halifax Co., Va., Deeds).

1 June 1767. John Chisum and Ellen, his wife, of the County of Pittsylvania, for 40 pounds current money, 50 acres in Pittsylvania County, south side of Stanton River, to John Dyer. (Signed) John Chisum, Eleanor Chisum. Wit: James Stevens, Elisha Dyer, James Dyer, Jr.. (Pittsylvania Co., Va., Deeds). (John Sr.)

1 June 1767. John Chisum of Pittsylvania County, for L-50, to James Chisum (Chisham), same county, 150 acres, south side Stanton River, being the upper part of 330 acres granted to Zachariah Green by patent bearing date at Williamsburg, 10 Aug. 1759, by him conveyed to the said John Chisham. (Pittsylvania Co., Va., Deeds). (Jno. Sr.)

June Court, 1767. Archibald Ingram, Plaintiff, vs. John Chisum, defendant. For reasons appearing to the Court, ordered that this suit be dismissed. (Pittsylvania Co., Va., Judgements).

23 Feb. 1768. John Beavers of Mecklenburg Co., Va., to Wm. Chisholm Jr. and his brother John Chisholm, of Cumberland Parish, Lunenburg, land in Lunenburg, south fork of Falls Creek, for 76 pounds. (Lunenburg Co. Va. Deeds XI, 197).

20 June 1770. Wm. Chisholm, Jr. and John Chisholm sell to Daniel Winn, 379 acres upon Little Hound and Falls Creek, 12 July 1770. Wit: John Graham, Wm. Chisholm, Sr. (Lunenburg Co., Va., Deeds XI, 404).

1769. Julius Deane of Bartlett County, South Carolina, to John Chisum of Halifax Co., Va., land on both sides of Spider Creek, granted first to Edward Deane, 125 acres. (Halifax Co., Va., Deeds). (1756 -- Chas. Deane).

27 June 1773. John Chisum and James Chisum of Halifax County to John Fitzpatrick of Bedford County, for L 222, 400 acres in Pittsylvania, south side of Staunton River, opposite Randolph's Long Island. (Signed) John Chisum, James Chisum. Wit: Elijah Chisum, John Estes. 24 June 1773. (Halifax Co., Va., Deeds).

30 Mar. 1771. Joseph Lewis of Halifax County to James Chisum, for L 30 current money of Virginia, 100 acres on a branch of Turable Creek, known by the name of Grindstone Fork, in the County of Halifax. Wit: James Bates, Sam'l Bates, Fleming Bates, Jr. (Halifax Co., Va., Deeds).

8 Jan. 1773. Nicholas Gillington of Halifax County, for love and affection, to John Chisum and my daughter Ellener, his wife, of Halifax County, all my goods, chattels, leases, debts, plate, jewels, etc., and my other substance whatsoever, moveable and unmoveable, of what kind, nature and quality so ever. (Signed) Nicholas Gillington (Seal). Wit: John Dyer, Cloe Chisum, Mary Bryant, John Dyer, Jr. (Halifax Co., Va., Deeds IX, p. 12).

28 Jan. 1773. Lorry and seisin was delivered by the within named Nicholas Gillington unto the said John Chisum of one pillow in the name of all the goods and chattels within mentioned.

1772. Copy of will of Nicholas Gillington. In the name of God, Amen. I, Nicholas Gillington of Halifax County, being weak in body but in sound and perfect sense and memory, thanks be to God for the same, calling to mind that men must die and after that must come to judgment, do consider that what of our affairs are not settled in this life cannot be settled hereafter, do make and ordain this my last will and testament, acknowledging this to be my last will and testament, disannulling all other will or wills whatsoever, and to proceed, I shall give my estate as followeth, to-wit: I give to my daughter Catherine Brown one feather bed, to her and her heirs; to Elizabeth Collins, I give one feather bed, to her and her heirs; to Elizabeth Chisum, daughter of John Chisum, I give one feather bed, to her and her heirs; to my son John Gillington, I have given 400 acres of land which I intended should have been his full portion, nevertheless, to make matters out of dispute, I give to his heir five pounds cash. To John Chisum, I give my land and plantation which I now possess in Amelia County, containing 300 acres, to be at his own disposal, for which reason he is to pay to Catherine Brown or to her heirs, twenty pounds current money; to Elizabeth Collins or her heirs, twenty pounds; to Anne Hillsman or her heirs, twenty pounds; to Eleanor Chisum or her heirs, twenty pounds; to Priscilla Hendrick, my granddaughter, or her heirs, twenty pounds; and as for my negro woman, Rose, she shall choose her mistress among my daughters and they that she shall choose shall pay twenty pounds to be equally divided among all my children now living and my two granddaughters, which is Elizabeth Chisum, wife of John Estes, and Jarushea, daughter of John Gillington, deceased. I therefore make and ordain John Chisum my whole and sole executor of this my last will, acknowledging this to be my last will and testament, made in the year of our Lord one thousand seven hundred and seventy two and on the twenty-first day of October. In witness whereof I have hereunto set my hand. (Signed) Nicholas Gillington. Wit: John Dyer, John Templeton, James Chisum, Elizabeth Lark. (Halifax Co. Va., Wills I, 55).

1773. At a Court continued and held for Halifax County, the 16th December 1773, this last will and testament of Nicholas Gillington, dec'd, was proved by the oath of James Chisum, witness thereto and ordered to be certified. Test. P. Carrington, Clerk.

1774. At a Court held for Halifax County, the 20th January 1774, this last will and testament of Nicholas Gillington, deceased, was farther proved by the oath of another of the witnesses hereto and ordered to be recorded. And on the motion of John Chisum, the executor herein named, who made oath according to law, certificate was granted to him for obtaining a probate hereof in due form, giving security. Whereupon he, together with Moses Estis, senior, Byrd Prewit, Moses Estis, Junior, William Gent, Robert Brumfield, Thomas Tinsley and John Estis, his securities, entered into acknowledged their bond with conditions according to law. Amelia County, Virginia, Wills I, 71, shows that Nicholas Gillington made will a year earlier, November 2, 1771. In it he mentions a grandson, William Gillentine, not named in the Halifax will. The executors named in this will were "friends George Booker, Thomas Munford." Wit. Matthew Hillsman, James Garrett, Robert Willson.

5 Nov. 1775. William Graves of Granville County, North Carolina, to David Chisholm of Hanover County, Virginia, 400 acres, both sides of Goochland Road, and some of the branches of Beaver Dam. Wit: John Austin, Wm. Poindexter, Wm. Chisholm, Martha x Ford Parish. (Louisa Co. Va. Deeds E, 87). (Wm. Graves from Louisa Co.)

1778. Tax List of Henry Co. Va. John Chisum & Elijah Chisum.

There seems to be a lack of records during the Revolutionary period.

(Halifax Co., Va.)

25 July 1784. Adam Chisholm, Drucilla Phelps, Jno. Phelps, William Gates, Dulendst Buckner, witnesses to will of Thomas Farnborough. (Halifax Co., Va.)

16 April 1781. Thomas Flournoy deeds 217 acres to John Chisolm, branches of Bush River and Briery River, McChee's line. (Prince Edward Co., Va. Deeds VI, 453).

19 May 1783. John Chisolm of Prince Edward Co., Va. to William Hines, for 100 lbs. 217 acres in Prince Edward County on branches of Bush River and Brier River, McChee's line. (Signed) John Chisolm (Seal). (Prince Edward Co., Va., Deeds VI, 521).

First Census, 1790, North Carolina, gives the following as living in Rockingham County: John Chisholm, 1- 2- 2- -- (2 blacks). Rockingham is just across the line from Henry County, Va., which was taken from Pittsylvania and that from Halifax -- records in all these counties of Chisholms. I take the Rockingham family to be an offshoot from the Virginia family. A Chisholm descendant living now in Tennessee says his "Captain John Chisholm (Red Buck)" was born in Rockingham, Virginia, Jan. 28, 1779;

died May 9, 1861, Greenhill, Alabama; married Sarah Greenwood of Maryland. Issue: Lucinda, Rufus King, Alexander Claiborn, Enoch Parsons, Jack Norton, Joe MacHenry, Izilla Kilpatrick, Angeline, Benjamin Franklin, Louisa Jane, and James Russell Chisholm. I imagine this Captain John to be one of the males under age in the First Census of Rockingham Co., North Carolina. I imagine this John of the census, to be connected with my family, on account of similar names, but he can hardly be the John of Watauga. *Note - MVB. This John was son of Wm + Deborah. He m. 18 Feb 1782 Elizabeth Muse. See old letter of Elijah Sr - speaks of "Uncle John"*

JAMES CHISHOLM, named in a list of Justices of the Peace in Lancaster County, Virginia, from 1680 to 1778. (Virginia Hist. Mag. IX, 222).

WILL OF WILLIAM CHISHOLM

Charlotte Co., Va., Will Book 2, p. 24.

In the Name of God, Amen. I, William Chisloam of the County of Charlotte and the State of Virginia, being of sound mind and memory do make and establish this to be my last Will & Testament, that is to say:

I give to my son William Chesloam my negro man Amos whom he now has in possession;

I give to my son John Chesloam's children; Jincey; William; John; Alexander; and Andrew my negro man Jack.

I give to my daughter Margaret Davis the following negroes, viz: Fann, a woman; Tom a man; and Ned a man; which negroes she now has in possession.

I give to my daughter Sarah the following negroes, viz; Philidia, a woman and her increase whom she now has in her possession, and Moses, a man she is to have after the death of my wife Debroh.

I give to my daughter Anna my negro woman Lucy, the mother of my negro woman Fann, whom she is to have possession of after the death of my wife. But as the said negro is not equal in value with the portions of the rest of the children, I desire that the woman Lucy be valued and the deficiency made up by the other legatees of this will, and she is to be valued at the death of my wife.

I give to my daughter Mary Easter thirty pounds to be laid out in buying a negro girl, which money is to be paid out of the money arising from the sale of land to Langston Bacon and John Petty. But if the negro when purchased is found of less value than the portions of the other legatees, I desire that she shall be made equal by the other legatees of this will.

I give to my wife Debroh during her life the following negroes, viz; Jack, a man; Lucy his wife; and Nate, a man, and after the death of wife, it is my will that the said negroes Jack, Lucy and Nate be equally among my children William; Margaret; Sarah; John Chisloam's children Jincey, William, John, Alexander and Andrew; Anna my daughter; Mary Easter and Elizabeth Terrell.

Lastly, I do appoint my friend Edward Almond Executor of this my last Will & Testament, as witness my hand and seal this 20th day of January 1789.

Proved 4th day of June 1792 by Beverly Callicutt & Bartlett James and ordered Recorded. Edward Almond renounced in open Court the burden of the execution of the said Will.

2 Jan. 1815. David Chisholm's CHISUM - CHISHOLM; sister Ann Collins; Peter Debra; Chisholm, youngest daughter of brother Thomas by his first wife; all estate to John Chisum the elder d. in Caroline Co., Va., in 1734. He had sons:
 (This is 1. John Chisum who married Eleanor Gilington of King William & Caroline Co. Marriage 2. William Chisholm who married Deborah Cook of Elizabeth City Co., Va. 3. Alexander Chisholm whose wife is unknown. 4. James Chisholm whose wife is not known.

6 Oct. 1815. Legatees: Mrs. Nancy Smith, Obadiah Chisholm, Samuel Chisholm. John and Eleanor and William and Deborah went to Amelia Co., Va., in 1743, and about 1744 John Chisum, son of John & Eleanor, married Margaret Chisholm daughter of William and Deborah. About 1752 John and Margaret moved to the part of Halifax Co., which was cut off into Pittsylvania Co., when it was created. I do not know when they moved to Tenn., but both (John Chisum and son Elijah) were living there when they served in the Revolution. It was North Carolina service, because Tenn., was then part of North Carolina.

On 26 March 1783 Jonathan Courtney received a grant of 100 A., Claim # 1878. Some time later he sold this 100 A., to John Chisum, who paid for it but for some reason did not receive a Deed for it. Co., S. C.). (from Harover and Louisa Co., Va.).

About 1787, John Chisum died, and his widow Margaret married, about 1788, Virgi Davis. Chisholm, J.

Finally, in 1792, Jonathan Courtney prepared a Deed for the 100 Acres of land, which read "I do hereby assign over my wright & Title & claim of the within Warrant unto the heirs of John Chisum, named Isham, Anney, Elijah and Cloway Chisom, als Davis. Witness my hand this 24th day of Novoth 1792.

A line was drawn through the John-Chisum and above it was inserted Margaret Davis. CHISHOLM MARRIAGES:

The land was surveyed 11 Dec. 1792 by Deputy Surveyor James McCarty and described as 100 A "on a meander of the Holston, about 2 miles below the mouth of German Creek" for the heirs of John Chisom, Isham, Anney, Elijah & Cloway Chisom. Wit: James Nicholson; Fra. Nicholson. William Chisom - Deborah Cook, daughter of John Cook of Elizabeth City County, Virginia.

The chief of the clan is always distinguished as The Chisholm. One line of Chisums in Tennessee is Baptist but I am not yet able to connect it with Elijah.)

He was from Bedford County, Virginia. I am sure, because a Read married a Phelps in Bedford"). (Overton County, Tennessee).

"There are no authentic records of, nor any information of any expedition of white men, nor any individual white man having set his foot on Madison County soil previous to about 1817 or 1818." The County, organized in 1820, was named in honor of President Madison.

Claiborn Chisholm, one of adm'rs of estate of said John Chisholm, dec'd, made oath, Feb. 1836. Negroes names: Doctor, 4 years; Bill, 43; Jim, 60. (Old Book, p. 47).

1837. Pursuant to order of County Court of Madison, Thomas Reid, John Vincent, Jr., and J. R. Graves, a commission appointed to settle with Laban Dodson, present guardian, John W. Smith and Claiborn Chisum, adm'rs of John Chism, former guardian of James and William Chism, late of Madison County. (Old Book, p. 224).

8 Apr. 1837. Commission to settle with Laban Dodson, guardian of Gains Chism, dec'd, Larkin Cason, administrator of said dec'd..... said Gains Chism entitled to \$548.14½. (Old Book, p. 228).

Larkin Cason, guardian of Gains Chisum. (Old Book, p. 241).

4 Sept. 1837. Order of Court, August Term, 1837, to settle with Claiborn Chism, former guardian for Elijah Chism, John Chism, and Elizabeth Chism, the minor heirs of William H. Chism, dec'd. C. H. Robertson, receipt for schooling Elijah and John Chism, \$6.31½. Commission: John W. Smith, Archibald Summers.

1836. Nancy Chism sells share of land deeded by John Chism to her and her three sons, Vanransalaer, Edmond P. G., and William Chisum, minor heirs of William Chisum, dec'd.

1840. John Chisum's estate. Vann R. Chisum, Claiborne Chisum, Mary Ann Chisum, John Johnson. (Madison Co., Tenn., Wills III, 250).

1842. John Chisum's estate settled with William Chisum and John W. Smith, adm'rs of John Chisum. Estate paid: W. H. Chisum, Elizabeth Chisum, Thomas B. Mercer, James M. Vinson, Martha J. Chisum by her guardian, W. H. Chisum, and Edwin C. Stevens. (John Chisum died in 1833 and this is probably the final accounting of his estate.

James Anderson of White County, Tenn., was married in said county to Rebecca Hill, who was the legitimate daughter of William Hill and wife Lucinda Hill, formerly Lucinda Chisum, daughter of the late James Chisum of Hardeman County. Lucinda Hill is now dead. The wife of Anderson is entitled to distributive share of estate of James Chisum; and likewise to certain portion of estate of James S. Chisum, lately deceased, being son of James Chisum; both died intestate. Anderson gives power of attorney to William Hill, for wife Rebecca Anderson of White County. (Hardeman County, Deeds E, 96).

1836. Settlement with Robert H. Vernon, adm'r of estate of James S. Chisum. Recorded 21 Sept. 1836.

21 July 1837. Claiborne Chisum, Thomas G. Chisum, John Johnson and wife Polly, Walter Robinson and wife Rebecca, Andrew Turner and wife Levina, Jonah Robinson and wife Elizabeth, to Robert H. Vernon (whose wife was Nancy Epps Chisum), claim they may be entitled to at death of Elizabeth Chisum, widow of James, in dower. (All heirs to James Chisum). (Hardeman Co., Tenn., Deeds, E., 287.)

26 Aug. 1837. Claiborne Chisum, about to move to Texas power of attorney to Pitser Miller.

19 Aug. 1837. John Johnson, power of attorney to son James M. Atwood, John Lovelady. Reg. 17 Jan. 1838. Cancelled 9 Apr. 1839, by parties themselves being present. (John Johnson was also "about to move to Texas." Maclin, Sec'y of State, issued 2 Wts. to Elijah Chisum, No. 41 for 129 A. and No. 42 for 100 A. It is recited in both documents that they were issued from a grant in the name of Elijah Chisum for 640 A., being grant #732, dated 20 July 1797, and both say "obtained by virtue of the 50 shilling warrant - - - Further: "Minute Book No. 1, Commissioners Court", p. 314 On 24 Oct 1807, the above wts #41 and #42 were rejected, and it was again recited that they were issued from Grant #732, dated 20 July 1796, to Entry #359, Adairs Office." Mr. Cox says "I have searched diligently for Grant #732, dated July 20, 1796, but find no record thereof, nor do I find any record of Entry #359."

The above might indicate that Elijah Chisum lived in a remote section of Jackson Co., which in 1806 became Overton Co., where his son James was settled before that date. James remained in Overton Co., where he became a founder and one of the trustees of "Fiske Female Academy", the first girls school in "the Territory South of the Ohio" and from 1819 to the time they moved to Hardeman Co., Tenn., a member of the Tenn. Legislature.

CHISUM LETTERS

James Chisum, Esq., Overton County (Tenn.) Novem^r the 24th, 1806.
Sir: I arrived at home Saturday last and had a long and tiresome journey of it. I had Long's land surveyed. The price of the work was 3 dollars sixty-two and a half cents, and one Dollar for the Chain Bearers, which amounted to \$4.62½. I received the balance, all but 13 Dollars, for which I gave them credit on the Note, for I also send your money to you that I got from Rice, only some few cents I made way with. Wm. Rice sent his compliments to you and said if he can do any favor for you he would be happy in return of the same compliment. I stayed in Nashville the first week. There were but 3 suits tried. The suit of John and Tayler was the 36th on the Docket and of course could not come on this Court. There was also 4 criminals to try which would take up some time, etc. Uncle John has brought a scandal on himself and never can make good the breach and that is this. He had let Barats bond go out of his hands to get something from Barats, and the persons that have it have gone down and demanded the land and say they will have it if the law will give it to them. This has much surprised the old people in so much that they went and got the advice of a lawyer and had to give 2 Dollars and fifty cents, and wish the money to stay in your hands till he lifts that said bond, as he is worth nothing or so little that he cannot make it good, etc. You can get the money whenever applied for. It is all in gold but 2 Dollars. I am, Sir, Yours ac., Elijah Chisum *father of James*

Letter from James Chisum to his parents, Elijah & Lucy Chisum (sent by hand) pr Mr. George Ammerino: 29th July 1811. Dear Father and Mother: In haste I inform you that my daughter Polly is at the point of death, apparently having taken cold about the 8th or 9th day after she had her little one (which was evening before last she took cold) and in a few hours was so violently affected that she would grip her hands together and would shake all over as with the most violent ague. She has been very much sweated and last night we thought she was mending, but this morning has a high fever, and does not know me or Johnson from other persons but still wishes us present. Her mother is perhaps the only person she knows. She says she is sick and her Granny Chisum could cure her. I did not conclude to send for you until she mentioned it herself, knowing you are both illly able to ride at this time, judging from your indisposition when I left you, but as it is her request I complied knowing you would come if in your power. Your Son, James Chisum

Letter from Elijah & Lucy Chisum to James and Betsey Chisum. (Undated)
The same day this came to hand. Very dr Son: Your mother is all but out of her head with a rising in the palm of her hand. Some call it a Catarrh. It at present appears as bad as ever I saw. She is also very sick with the pain. I believe her hand began to rise the next day (after) you left us. She is at this time with bitter tears on poor Polly's account, knowing it will be out of her power to come to her assistance. I have 2 days ago got shut of my complaint, and your mother is in the case I write you (so) that it appears I cannot leave her, especially when I could not do any good to my dear granddaughter. May the Lord apply his balm to her soul, I pray. Farewell, Elijah & Lucy Chisum.

(Polly Chisum Johnson's illness followed the birth of her first child; she recovered and became the mother of fourteen other children).

My dear Cousin:

Your kind letter of the 16th inst. has been rec'd. I was so glad to hear from you. I noticed my mistake in answering your question as to who was the wife of Maj. James Chisum's Bro. John. I did not refer to your letter when answering but just wrote from memory & I was thinking of the son of Maj. James. I intended to correct this when I wrote again. And another mistake- I wrote that I had never heard of Grandpa Vernon having any brothers or sisters, but as soon as I read your letter & you mentioned Uncle Miles Vernon, I recalled that I had heard of it before but had forgotten it. Now I want to ask you some questions about the Chisums. How many sons did Maj. James Chisum have? Uncle John was one, and who was James S. Chisum? He must have been a son of Maj. James, as I notice his name often among some old papers that I have, and his daughters were Grandma Vernon and Grandma Robinson, and Aunt Betsey (wife of Jonas) and Aunt Viny Turner. This would be 6 children. Now I would like to know about Maj. James' brothers and sisters. Thomas and Claiborne & John, and I know of no sisters of Maj. James Chisum. I think Cousin Catherine Mercer (T.E. Mercer's mother) and Cousin William Chisum on Dry Creek in Madison Co., were children of Claiborne Chisum. I suppose Cow John was a son of Claiborne, and half brother of Robt. C. Chisum who died in Arlington, Texas. I believe Aunt Malinda who married Thomas Chisum was a daughter of John Chisum, and Lucinda was a sister of Malinda. So both were daughters of John Chisum. Now I will tell you about Uncle Jim Vernon's children. They are all dead. Wannie, B.F. (Frank), Emma, Carroll and Sam. Wannie married Charley Stevens, a Michigander, but she did not live long after her marriage, and after her death Charley Stevens married Emma, and they had some children, but I know nothing of them. Frank was never married. Carroll married Miss Josie, but both she and Laura Prothro both spelled it Jossie. They raised 8 children, 6 girls and 2 boys, but their oldest girl died. Sam married but he and his wife are both dead. They have 4 children living and they have no means of support. I received a letter from Miss Jossie and Laura Prothro about a week ago. They are living at Uncle Jim's old place. All Carrolls children are married. One lives in Dallas, one at Fort Arthur and the rest of them live around in the community. Gladewater is their Post Office. Cousin James Prothro died about 3 or 4 years ago, and Laura could not live alone, so she came to live with Carrolls wife for a while, and maybe some others also. Charley Stevens was a tall man, red complected & had a red mustache. He was at one time Sheriff of Gregg Co. but he was farming in 1880. He seemed to be a good farmer & very industrious. He liked to change teams at noon & get another team for the afternoon so they could rest and graze. He and Emma may have some grown children, but a relative of Charley's (an Uncle, I believe) came down from Michigan and shot and killed him while he was plowing in the field. Charley seemed to like Ma and myself, and he thought there was no one like Dr. Vernon. Uncle James taught school at Antioch and he had a good reputation as a teacher. He had a good school. Some Boarding pupils, two of whom boarded at our house. I believe this was about 1870 to 74, & later. Wannie was right well advanced in her studies. She and Sammons Anderson studied Latin and I remember it would take them quite a while to recite. I went to school at Antioch to several different teachers, and a little at Coopers School House, and I went the Spring term at Long View, Tex. in 1880. After I came back I went to Clover Port Academy again, and in the spring of 1883 I attended the Toone School and there is where I quituated. Myself and several other boys from Clover Port Academy went to Jackson to be Examined by the Supt. of Education as some of them intended to teach. I just went to be going and made a little better grade than any of them. I am enclosing a letter I received from Robt. F. Vernon while he was Tele. operator at Toone and not long before he shot himself. You may just keep this letter. And I would like to hear from you again. Your Cousin Walter R. Robinson.

My dear Cousin:

Your letter of 2nd inst. was duly rec'd. I am getting better straightened out about our relatives. After your letter came, I had one from Laura Prothro of Gladewater and she said her father was Thos. G. Chisum, so Thos. G. and Claiborne were sons of Maj. James Chisum. Thos. G. married Aunt Malinda. John Chisum, Aunt Malinda's father was a brother of Maj. James, and I do not know who John married. In giving the names of the children of Maj. James & Elizabeth Gibbons Chisum, you state that ~~NAME~~ Elizabeth Chisum born Aug. 27, 1812 married Jonas Robinson. No doubt this was Aunt Betsy. I never knew her by any other name. I suppose it was Betsy Elizabeth. And she did live a long time after her husband's death, as you state. But here is a mistake, in speaking of Walter Robinson and Jonas Robinson you say they were sons of Cumberland Robinson. No, they were brothers of Cumberland, and these 3 brothers were sons of Edward Robinson of Jackson Co., Tenn. This Edward Robinson and wife Ann came from Cumberland Co., Va.; besides these 3, there were about 6 or 7 other children. I sent a copy of the list of their names and a copy of the will of Edw. Robinson to my cousin in Cookeville, Tenn. She is getting up a history of the Robinson Family. But before I get too far off the subject I will give you the names of the children of Aunt Betsy and Jonas Robinson. James L.; Billie; Old; Dr. T.J.; Wiley; Pitzer; Nancy Ann married a Mercer and Lucy Jane married a Pirtle first and later a Crews. Dr. T. J. Robinson was a very popular physician at Clover Port and later moved to Marianna, Ark. He played the violin very well and belonged to the Clover Port Band. His son Dr. Claiborne Robinson also practiced at Marianna. Cousin Nan Tom as she was called was so jolly and lively.

Now I will give you the names of the children of Uncle John C. and Eliza Pirtle Chisum. James; William; Nannie; Lizzie; Rebecca; Fusa; and Nora. Nora is the only one living. She is Mrs. R. W. Hensley of Covington, Tenn. John C. lived at Blytheville, Ark. But wait. Uncle John had another daughter Mary who married first a Harris and after an Alison. Uncle John and Aunt Eliza partly raised Lou and Adelaide and Nannie Harris.

You asked if the Louis Wood mentioned in Uncle Jim Vernons letter a son of Cousin Sallie who married a Wood. I do not know. You asked who the Tee was that Carroll referred to as preparing to go to Navarre Co. I think that Tee was Cousin Emma's husband. I think she married again after Charley Stevens was killed. I am sending you 2 more of Carrolls letters to Mama, and now I have still one more of Carrolls, but it and one more of Uncle Jim's I will sent next time. I will send the ones of Carrolls you returned to Mrs. Josie when I write to her. Where were you reared? Mostly in Texas, I suppose. I liked Texas fine and I reckon I would have been rich if I had stayed there. Carroll, Johnnie ~~NAME~~ Smith and I went west in 1880 in a wagon as far as Concho Co. I killed a deer near Uncle Jim's in 1880. Your Cousin

Dear Aunt:

I am ashamed of myself for not answering your letter sooner, but howsoever, here goes. All well and hard at work. Health good generally speaking, and everybody picking cotton to beat thunder, though we are behind with our picking worse than anybody on account of hauling rails for a pasture. Mules work bully. I have taken off 4 bales of cotton, 3 for Pa and 1 for me. We have cut one more. We will make 12 or 13 on the place. Henry has sold 7 bales & got 2 more out. Picked it all themselves. He will make 13 bales. Uncle Sam will make 4, he has cut 2. Joel Smith will make 18, he has cut 8 or 9. Charley will make 16 or 17. He has sold 8. Cotton is low. Charley has sold out his market for \$175.00. He stayed at home when he run it, just hired a man to tend it for him. Pa has withdrawn from his race as candidate. I cannot tell why, hardly. Just tired of it, I reckon. Tee left here this morning for Navarro County. We will have a party tomorrow night at Mr. Ford's up at Mrs. Jefferies place. I am going to take Miss Josie up in the wagon (and aint she pretty). I have some gay times with Miss Josie, Aunt Helen. Won't I dance with her tomorrow night (and don't it snow in Texas). I'll make us think so at the party. Aunt Helen, I'm in a hurry & haven't any more time just now. Can't answer Walter now for I have only one envelope. I cannot come to Tenn. this winter, Aunt Helen, for certain reasons. I will tell you at another day. I'm sorry though that I can't. I saw Mr. Campbell the other day. He is as gay as a D---hill rooster, and as good looking as ever. He trips along so peart that you can hear a kind of a buzz or something about him. I could if I had time tell you a heap of little occurrences, but I have not time just now. So write to me soon. Give my regards to everybody and more too. Yours as ever, Carroll Vernon.

(I have a note that Carroll married Miss Josie and had 8 children. She was still living when Cousin Walter sent me the original of the letter, and I begged him to send it to her- about 1934, I think, and he said he would. In 1939 I passed thru Gladeater and tried to get her on the phone, but failed).

Dear Aunt:

I intended to answer your letter in a few days after I got it, but first one thing and another kept me from doing so. My folks, Ma, Emma and Sam are all well. We are all right here together you might say. I am where I built several years ago. Emma and Tee are in the house with Ma. Sam and Vickie are where Uncle Sam Wilkins used to live. Aunt Helen, times are very hard with us. As long as we are under Republican or Democratic rule we will have hard times only worse. Tee will stay in the house with Ma next year. Sam and Vickie will stay where they are, I reckon. I will stay where I am. Cousin Martha Smith is still living at the same place. She still complains about her head. Frank Vernon is well entirely of his trouble. He can do more work now than I can. I was at Uncle Jim Frothos yesterday. Uncle Jim and Aunt Laura are well. They are not done gathering their crop yet. They will have to look out a new home right away. 5 or 6 years ago Uncle Jim bought out all the old place and borrowed money on the place to pay for it from a Loan Company and he failed to pay for it. They do not know where they will locate yet. Josie's mother is with us now. I do not know how long she will stay. The old lady Brashear is still living at her old place. Aunt Helen, I can't find out anything about the Chisum you spoke of in your letter.

I am of the opinion though that he was the Chisum once known about 40 years

ago here as Cherokee John. He moved in an early day to Cherokee Co., Texas from here. The name Cherokee was given him to distinguish him from Cow John Ma says. We know but very little about them. In fact now we know nothing. About 40 years ago a William Chisum, known as Pool Bill lived in this County. He went Southwest somewhere. I would be glad indeed if something would turn up that would give us all a lift out of these tight times. Uncle Toll Chisum left Southwest Texas this fall for the Indian Territory. I have never heard whether he got there or not. And I don't know what point he was making for. Aunt Helen, excuse my short and uninteresting letter. I will do better next time. I would like to see you all. I could ask you a thousand questions if I was with you. I have forgotten many of my cousins names that I used to know back there. I am nearly gray headed. I am 40 years young today (Dec 17)

But I feel much younger than that. I have 5 children. Jessie C. Vernon age 11, Nannie 8½, Cora Lee 6, Emma Pent(?) age 3. Sammy my baby is 1 year old in Sept. Sam and Vickie have 2 children. Crawford is 2½ years old. Their baby is 9 months old and I have forgotten its name. Tee and Emma have 3 children. Tommy is 4½ years old, John Selon 2½ years and the baby Samuel Kendrick is 2 weeks old. Write soon, Aunt Helen, and I will be more punctual after this in answering your letters. Dear Aunt:

I will write you a few lines tonight. We are all well. No farming to amount to much. The cold weather has been terrible. Ma got a letter from Uncle Toll Chisum the other day. I will send the letter to you. Uncle Toll wants to try to prove up Indian blood. Ma says tell you to trace the Chisums back all you can. When my Grandma Chisum lived in Tennessee, she was visited once in a while by a John Chisum from Alabama. Grandma called him Alabama John. Probably some of the old people there could trace these Chisums up. Ma says that Pa used to tell her that when the Indians were moved from Alabama to the Nation that one of the Vernons (Admiral Vernon) was Commander-in-Chief I believe in moving them. Now we don't know just what kin he was to us. Ma thinks probably he was Pa's uncle or great-uncle. If we could trace these Vernons and Chisums back we might find out a great deal. You see old Uncle John Chisum and all the old ones of the connection and learn all you can about where they come from and to whom they were connected and how. I will write more when I hear from you if I live. My fingers are sore and stiff tonight. I have been roping and branding cattle yesterday and today, and it is hard work. I will drive them tomorrow and next day. The operator at Gladewater said this evening that another norther was reported coming, expecting it tomorrow. Write soon and give all the news.

I will now commence to answer your letter which I received about the first of the month, and I will also write for Ma as she never writes any. We were glad to hear from you and to hear that you were all well. Ma was proud of Charlies and Eds pictures. But sorry we have none to send to you. We are all well and getting along just tolerably well. I have more work to do be-

fore plow time than I can do. I have Ma's house to ^{re}cover. Lots of fencing to do and land to clear. Just about the time I get ready to go at regular work it will rain a day or so. Then get wood a while or do something else. So the wubter will soon be gone and all this work to do. It is so wet now that I can't haul anything. I have given up all hopes of ever making anything more than a living. It matters not what we raise we can't get a good price for it. \$50.00 cash will get as good a farm mule as I want. Texas ponies are selling from \$10.00 to \$20.00. Some a great deal less. Cows and yearlings are a good price, but there are none to amount to anything to sell. All kinds of farm produce is too low for a person to make anything raising it. Ribbon Cane syrup sells for 35 cents per gallon, though it beats cotton. This past year good land well worked made at the rate of 400 gallons per acre.

I have land that will grow good cane but it is not cleared now. Nor I have-n't any seed cane to amount to much. Aunt Helen, let me tell you now and for all time, I think I know what I am talking about. The past cotton crop is estimated now at 77 million bales. It is called overproduction. It makes me sick to hear people talk about overproduction. Don't any common sense person know that if the people had the means to buy with that no surplus would be left over/. There are all over the world thousands and thousands that can't get the money to buy our cotton goods. It is all on account of money being so scarce, and money has been made scarce by the two corrupt old parties. A nation without plenty of money in circulation is full of idle men, tramps &. A Nation without money enough in circulation is brim full of criminals of all sorts. Scarcity of money makes the rich richer very fast and the poorm poorer. Now what I am going to tell you, we never will I tell yousee plenty of money and be prosperous as long as we live under the administration of either the Republican or Democratic parties. Never will I say. Old Parties never reform themselves. Good Night.

Paralee has just taken off her first hen with young chickens this morning. She has 3 or 4 old geese setting. She generally has very bad luck with goslings. Sometimes they die, sometimes they get drowned, sometimes the old sow eats them up. She never raises over from 1 to 3 or 4 a year. She has about 20 head of old geese now. Paralee had some of the boys running around before daylight this morning hunting up the April Pools scattered around in the country. She sent Louis Wood on a message to Carroll this morning and he lit out of bed and went winding, but he never came back till way after breakfast, and slipped in and got his mule and went to plowing. He is the worst sold fellow I ever saw and he was just talking last night about this morning being the first of April, then bit at the first bait thrown at him. So goes the world. I have been writing this letter several days as you can see. We are still well. Paralee aims to go down to Jim Protheros on Sunday to bring her mother up to stay with us. Aunt Melinda is still feeble, but she walks about the house and yard a little every day. She is generally very cheerful and lively and she is one of the best old women in the world. I don't think she can hold out to live many years longer, but I think she feels ready to die at any time, and really wants to die, I think. Aunt Melinda has been one of the most faithful and truest women the world has ever produced. I don't think they ever get any better. I have often said she was the best woman I ever knew. James Prothero and Laura are getting along pretty well. Laura delights in dress and so on. She and Mrs. Sparkes who lives right at the store always together, and spend much time making fine dressing and visiting. Joel Smith and family are well. Joel is boring with a big auger this year. He is planting about 60 acres in corn and 75 in cotton, besides a good many oats. He has bought 3 or 4 more mules. There
